

# Terms of Service

**Effective date:** February 25, 2026

These Terms of Service (“Terms”) govern your use of the services and communications provided by **TCC** (“we,” “us,” or “our”), including our person-to-person text messaging (SMS) communications. By contacting us, texting our number, or otherwise using our services, you agree to these Terms.

## SMS Terms Summary

- Message frequency varies.
- Message & data rates may apply.
- Reply **STOP** to opt out. Reply **HELP** for assistance.

## 1. Text Messaging (SMS)

If you provide your mobile number to TCC (including via a printed consent form) or you initiate contact by texting us, you consent to receive person-to-person SMS messages from TCC related to your request (for example, prayer requests, questions, or assistance). We do not send marketing or promotional SMS campaigns.

**Message frequency varies. Message & data rates may apply** depending on your mobile plan and carrier.

## 2. Opting Out and Help

- **Opt out:** Reply **STOP** at any time to stop receiving SMS messages. You may receive a final confirmation message.
- **Help:** Reply **HELP** for assistance, or contact us using the information in Section 8.

## 3. Acceptable Use

You agree not to misuse our services. For example, you agree not to:

- Send unlawful, threatening, abusive, harassing, defamatory, or obscene content to TCC.
- Attempt to interfere with our communications systems or impersonate others.
- Use our services in any way that violates applicable laws or regulations.

## 4. No Emergency Service

TCC's SMS messaging is not monitored 24/7 and is **not** an emergency service. If you are experiencing an emergency or need immediate help, call 911 (or your local emergency number).

## 5. Privacy
